Safety Marshals: Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the Meet Referee, any swimmer, coach, or club for the failure to follow the safety rules.

Facility: The Jamerson Y pool has 8 competition lanes. All are bottom striped and wall targeted with non-turbulent lane lines. Over head lighting is present. Bleacher seating, deck space and the gym is available for seating. Three 25 yard lanes available for warm up and warm down. Directions to the facility are available at www.swim4ly.com

Rules: The stricter of the 2005-2006 USA Swimming Rules and Regulations or the 2005 NCAA Swimming Rules will apply. Virginia Swimming, Inc. Safety and Warm-up procedures will be in effect.

Fees: \$2.00 swimmer fee, \$4.00 per event and \$13.00 for relays. Double the entry fees for late entries and time trials. Make checks payable to: **LY Swimming**

Format: Timed finals for all events. Distance events, #35-36, 61-62, will require a positive check-in 30 minutes before the completion of that session's warm-up. They will be swum slow to fast in event order.

Seeding: The meet will be seeded according to USAS guidelines.

Eligibility: This meet is a closed competition offered to YMCA teams and only those swimmers that have full membership privileges. All swimmers must be full privilege members of the YMCA they represent in competition and must be current on account with that YMCA and YMCA's swim team by the first day of the meet. Age on December 1, 2005 will determine the age for the entire meet.

Swimmers with Disability: Athlete members that meet the membership rules with disabilities are welcomed and shall provide advance notice of desired accommodations to the Meet Director. The athlete's coach is also responsible for notifying the session referee of any disability prior to the competition.

Entries: Hytek disk entries are preferred. If not, please use a VSI master entry sheet and complete it including the swimmer's full name, age, USAS number and sanctioned yard times. Also include a copy of your team's YMCA certificate of membership for all swimmers. Swimmers may enter a maximum of 4 individual events and 1 relay per day. Teams may enter up to 2 relays per relay event. Entries will be processed in the order they are received. The meet will be limited to the first 450 swimmers entered. The Meet Director reserves the right to limit entries in any event if deemed necessary. Checks should be made payable to **LY Swimming**. Hytek event file will be on the www.swim4LY.com web site.

Please sign the signature release line on all certified or express mail. Late entries will be accepted at twice the entry fee at the meet director's discretion.

Time Trials: Time trials will be conducted at the discretion of the meet referee/ director.

Timing: Colorado Timing Systems will be used. Timers from other teams are encouraged and are much appreciated. A one lane timer display is present.

Awards: Medals for 1-3 and Ribbons 4th-8th place for all individual events and Ribbons for relays 1-3rd. 8 & Unders will be awarded separately. Mystery prizes will also be given out.

Distance Events: All events 400 yards and longer, will be deck seeded and will require a positive check within 30 minutes of the start of that session's warm up. Swimmers failing to check in will be allowed to swim the event. Anyone missing a checked in event will be barred from swimming their next event. The meet referee will rule over any such decisions. The Meet Director reserves the right to limit the distance events based on time constraints.
